EDUCATION REPORT

Noelle Lenihan, Bronze Medallist in Rio Paralympics

The CE and Board paid fulsome tribute to Noelle Lenihan, a student in Hazelwood College Dromcollogher, on her historic achievement in winning a bronze medal for Ireland in the F38 Discus final at the Paralympics in Rio.

Noelle, the second youngest member of the Ireland Paralympics team at 16 years of age, in winning a bronze medal at the Olympic stadium in Rio and in the process set a Paralympic record for her classification.

It was a brilliant effort from Noelle who had to deal with waiting until the second last day of the Games for her event. Noelle had the added honour of being coached by her father, Jim. The CE and Board congratulated Noelle and all involved.

Leaving Certificate Results 2016

Congratulations to Principals and school staff teams on the excellent results achieved by students at Leaving Certificate Examinations. The Sunday Times League Tables, while we may not consider the criteria to be inclusive shows an improved rating for our schools. The results are a credit to school management and the commitment of staff teams in our schools in continuing to support students to attain to their potential.

Staff Induction

New staff took place on 25th August where workshops on Child Protection and Restorative Practices were delivered, as part of their induction new staff will also engage in a school based induction and support programme.

SNA Training

A two day training programme for SNAs was facilitated on 24th and 25th August. A working group of Principals, EO and Head of HR had designed the programme. Further training and supports are planned.

Opening of Thomond Community College

A new era for second level education on Limerick's north side officially dawned as Thomond Community College came into being on Thursday, 1st September, 2016.

The school – an amalgamation of Salesian Secondary School and St. Nessan's Community College celebrated as it enjoyed its initial intake of First Years, with 96 students starting out their five year second level education.

The First Year intake at the college is up 50% from three years ago when the amalgamation was announced. Overall numbers on the campus, which is located adjacent to Limerick Institute of Technology, is now 500, up from 320 in 2013.

In addition to the new First Year intake, Fifth Year and Second Year students from Salesian Secondary School have today transferred to the Thomond Community College, with all set to retain the teachers for the various subjects they had in the 2015/2016 school year at the Salesians.

FURTHER EDUCATION AND TRAINING REPORT

LCFE Night Programmes

Enrolment in night classes has commenced and there has been a swing back towards Business programmes, particularly in the area of Accounting Technician. Another area that has attracted increased interest is for qualifications as Special Needs Assistants. Classes commence on 26th September and it is hoped that there will be over 1,000 part time learners enrolled by then.

Day & Evening Programmes - Raheen Campus

- The first iteration of the Instrument Making class (Guitar making) finished during the summer period and there was a successful learner and staff event on the final date of the course where the learners showcased the beautiful instruments. The next intake of learners will start on September 19th.
- Classes for the autumn period have now recommenced with approximately 300 full-time learners undertaking adult and apprenticeship Phase 2 courses. Evening classes have started back and there will be approximately 180 learners undertaking evening courses with us on a Tuesday and Thursday night.
- Through the evening course delivery, a number of employed learners working in the Hairdressing industry were targeted with a view to offering them the opportunity to undertake City and Guilds L2 accredited modules and to build up their qualifications over time.

Apprenticeships

- The Phase 2 Toolmaking Apprenticeship has commenced. This apprenticeship was never offered through the FET Centre – Raheen Campus before.
- Registration numbers for the Standard Based Apprenticeship areas (Trade areas) are beginning to rise and it is hoped to be in a position to offer classes in other trade areas such as Plastering and Bricklaying early next year to add to the Phase 2 Apprenticeship offering.
- The 'new apprenticeship courses' have been launched and currently our Authorised Officers (Service to Business Training Advisors) are engaging with employers and newly registered apprentices in the fields of Industrial Electrical Engineering L7 of whom Limerick Institute of Technology is the Consortium lead and Insurance Practitioner L8 of whom Sligo Institute of Technology is the Consortium lead. Further 'new apprenticeship' courses will potentially be launched before the end of this year.

VTOS – Leaving Certificate Results

In August, there were great results for the 64 Leaving Certificate students in VTOS, Kilmallock Road Campus. Many are progressing to Third Level courses including ICT, Engineering, Science, Art & Design, Hospitality etc. A small number will progress directly into employment or continue for a second year on VTOS. VTOS got excellent coverage on the Limerick Leader publicising the occasion (see photos). This autumn, VTOS has already filled its 210 places and the Leaving Certificate programme is as popular as ever.

<u>Youthreach – Ennis Awards Ceremony</u>

Former and present Learners and staff from Ennis Youthreach had an Awards Ceremony. Awards were presented to learners from 2015 and 2016. Awards ranged from modules at QQI Level 3 & Level 4 to Full Certification at both these levels. Others choose to work on their own with a tutor to improve their reading and writing skills.

- Review of High level Goals Monitoring System with the EO, to facilitate multi-reporting demands on the implementation of the SOLAS, LCETB and FET Division goals and strategies.
- Work with Eimear to finalise publication of the LCETB FET Guidance Strategy.
- Support Yvonne Lane in the writing of the application for a UNESCO Learning City Award for Learning Limerick.

Guidance

In 2015 the AEO convened an Integrated Guidance Team to include PLC representation, Youthreach, advocates, training centre personnel. The objective of the team was to write a Strategic Guidance Framework for all activity in LCETB and this would link to the National FET Guidance Strategy. This document was printed in July 2016 and will be implemented 2016-2020. The framework provides mechanisms to enable all LCETB FET learners to avail of appropriate assessment and guidance information to enable informed choices for QQI progression or progression to workplace.

Employer Engagement

Eimear Brophy is currently attending the Workforce Development Planning Meetings with SOLAS as part of Employer Engagement Strategy. She will convene an Employer Engagement Forum within FET LCETB this Autumn with the objective of writing an Employer Engagement Strategic Framework as per FET Strategy.

Surveys have been carried out across the LCETB in the last year and this data provides a "real time" picture of employer engagement. The data will be used by the forum to write the vision of LCETB Employer Engagement Activation targets and to link to Regional Skills Strategy.

7. For Consideration: Finance Report

On the proposal of Mr. Tony Brazil, seconded by Cllr. Liam Galvin, the Finance Report was considered. In so doing, Mr. Brazil highlighted the work of the Finance Committee with regard to analysis of Water and Energy usage by schools and centres within the organisation. Mr. Brazil also highlighted the need for window replacements in schools which could provide significant savings in energy costs.

8. For Approval:- To sell LCETB lands at Clash Abbeyfeale

Mr. Eamon Murphy presented to the Board on the lands for sale in Abbeyfeale and informed the Board that the lands for sale comprised of 8.75 acres (3.54 hectares). Mr. Murphy gave the background on the lands and highlighted that the lands in question had not been used for in excess of twenty years and were accessible by narrow laneway. He advised Members that Board Members of St. Ita's Voluntary Housing Organisation approached the LCETB to acquire land for the purpose of provision of social housing/respite care.

The CE advised the Board that this was a reserved function of the Board and Mr. Murphy briefed the Members on the regulations pertaining to sale of lands under the remit of LCETB i.e. 1) no potential educational use for lands in question by LCETB or other educational providers, 2) No potential use by any other Public/Statutory Body, 3) Department of Education and Skills approval, 4) disposal to be at market value based on Red Book Valuation, 5) proceeds of sale to be returned to the Exchequer.

Mr. Murphy highlighted in his presentation the location of lands concerned, the valuation which the Department had now agreed and approved. Members also noted that a clause had been inserted in the sale agreement that lands could not be sold on for profit. Following a detailed discussion on the matter and the benefits to the locality, on the proposal of Cllr Liam Galvin, seconded by Cllr Mary Howard, the lands were unanimously agreed for sale.
